

**ORDINANCE 962**

**AN ORDINANCE APPROVING AND ADOPTING THE CITY OF PINEY POINT VILLAGE, TEXAS, BUDGETS FOR THE YEAR 2007; MAKING APPROPRIATIONS FOR THE CITY FOR SUCH YEAR AS REFLECTED IN SAID BUDGETS; ESTABLISHING THE PROCEDURE FOR INTRA-BUDGET TRANSFERS; AND CONTAINING OTHER PROVISIONS RELATING TO THE SUBJECT.**

**WHEREAS**, within the time and in the manner required by law, the Mayor presented to the City Council proposed budgets of expenditures of the City of Piney Point Village for the calendar year 2007, the same being the fiscal year of the City; and

**WHEREAS**, pursuant to a motion of the City Council and after notice required by law, a public hearing on such budgets were held at the Council Chamber, Piney Point Village City Office, 7721 San Felipe, Suite 100, Houston, Texas 77063-1629, on the 25<sup>th</sup> day of September 2006, at which hearing all citizens and taxpayers of the City had the right to be present and to be heard and those who requested to be heard were heard; and

**WHEREAS**, the City Council has considered the proposed budgets and has made such changes therein as in its judgment were warranted by law and were in the best interest of the citizens and taxpayers of the City; and

**WHEREAS**, a copy of such budgets has been filed with the City Administrator and the City Council now desires to approve and adopt the same; now, therefore,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PINEY POINT VILLAGE, TEXAS:**

**Section 1.** The facts and recitations set for the in the preamble of this Ordinance are hereby found to be true and correct.

**Section 2.** The City Council hereby approves and adopts budgets for the following funds: General Operating, Debt Service, Restricted and Capital Projects described in the preamble of this Ordinance, a copy of which is attached hereto and made a part of this Ordinance for all purposes and a copy of which is on file with the City Administrator. The City Administrator is hereby directed to place on said budgets an endorsement, which shall be signed by the City Administrator, which shall read as follows:

“The Original Budgets of the City of Piney Pint Village, Texas  
for the Year 2007”

Such Budgets, are thus endorsed, shall be kept on file in the office of the City Administrator as a public record.

**Section 3.** In support of said budgets and by virtue of the adoption thereof, including any and all changes adopted thereto, the several amounts specified for the various purposes named in said budget are hereby appropriated to and for such purposes.

**Section 4.** The City Council takes cognizance of the fact, that in order to facilitate operations of the City and its various departments and activities and to make adjustments occasioned by events transpiring during the year, some transfers may be necessary to and from some accounts contained within the budgets as originally adopted. Accordingly, should the Mayor from time to time determine that transfers are necessary from unexpended funds in one or more budget accounts to another budget account, and the same may be accomplished without creating a deficit in the requirements of any City Department or activity, she shall recommend such transfers to the City Council. Upon approval thereof by the City Council, an amendment sheet reflecting such transfer or transfers shall be attached to the budgets as specifically adopted, whereupon the City Council shall treat such funds as if they had been thus budgeted in the first instance.
