

ORDINANCE 987

STATE OF TEXAS § AN ORDER DECLARING THE RESULTS OF
COUNTY OF HARRIS § THE CITY OF PINEY POINT VILLAGE
§ GENERAL ELECTION OF MAY 10, 2008.

WHEREAS, The City Council of the City of Piney Point Village resolved and ordered that a General Election be held on May 10, 2008 in the City of Piney Point Village Texas for the purpose of electing the following City Officials to the City of Piney Point City Council:

MAYOR, COUNCIL POSITIONS 3 & 4

WHEREAS, there came on to be considered the returns of an election held on the 10th day of May 2008 for the purpose of electing a Mayor and two (2) members to the City Council,

WHEREAS, the returns of said election have been duly canvassed by the City Council, and there being cast at said election of a total of 864 votes, and each of the candidates in said election having received the following votes to wit:

IT IS, THEREFORE FOUND, DECLARED AND ORDERED by the City Council of the City of Piney Point Village that the above election was duly called. That notice of said election was duly posted and that said election was held in accordance with the laws of the Texas Election Code. That at said election Karey Bresenhan was elected Mayor of the City of Piney Point Village, Peter Nemeth was elected to Council Position 3 and Henry Kollenberg was elected to Council Position 4 of the City of Piney Point Village City Council subject to taking the oath.

SECTION 1: That it is further found and determined that the results of the election as canvassed and tabulated in the preamble hereof reflect the expressed desires of those persons voting at said election.

IT IS FURTHER FOUND AND DETERMINED that in accordance with the laws of the Texas Election Code, the Assistant to the City Administrator posted written notice of the date, place and subject of this meeting on the bulletin board located at City Hall. A place convenient and readily accessible to the general public, and said notice having been so posted and remaining posted continuously for at least 72 hours proceeding the scheduled time of said meeting. A copy of the returns of said posting shall be attached to the minutes of this meeting and shall be made as part hereof for all intents and purposes.
